WE OPENED THE SEASON WITH AN ALL-NEW PRODUCTION OF WEST SIDE STORY THAT FEATURED THE ORIGINAL JEROME ROBBINS CHOREOGRAPHY AND THE ORIGINAL ORCHESTRAL SCORE. WE THEN PRODUCED PUCCINI'S MADAMA BUTTERFLY, FOLLOWED BY MOZART'S COSI FAN TUTTE, THE LATTER CONDUCTED BY JANE GLOVER, ONE OF THE MOST RESPECTED INTERPRETERS OF MOZART AND A PIONEER FOR WOMEN ON THE PODIUM.
