OPERA PRODUCTIONS: THE LYRIC OPERA OF KANSAS CITY TYPICALLY PRODUCES FOUR MAINSTAGE OPERAS EACH SEASON, BUT IN THE 2019-20 SEASON WE ONLY STAGED THREE MAINSTAGE PRODUCTIONS BECAUSE THE SEASON WAS CUT SHORT BY THE COVID-19 PANDEMIC. OUR 2019-2020 SEASON, AS ORIGINALLY PLANNED, INCLUDED A THRILLING AND ADVENTUROUS NEW WORK (THE SHINING), AN IMAGINATIVE AND DELIGHTFUL RE-IMAGINING OF A MOZART CLASSIC (THE ABDUCTION FROM THE SERAGLIO), AND TWO POWERFUL AND BELOVED STORIES OF LOVE AND LOSS (LA BOHEME AND LUCIA DI LAMMERMOOR). BECAUSE OF THE COVID-19 PANDEMIC, WE HAD TO CANCEL OUR PRODUCTION OF THE SHINING AND THE LAST TWO PERFORMANCES OF LUCIA DI LAMMERMOOR. IN ADDITION, THE LYRIC PRODUCED TWO PROGRAMS FOR EXPLORATIONS, OUR SECOND STAGE PERFORMANCE SERIES. IN ALL, WE ISSUED 11,989 TICKETS FOR OUR ARTISTIC
