IN ADDITION, THE LYRIC PRODUCED A HISTORY OF OPERA (OPERA IN EIGHT PARTS) WHICH WAS DISTRIBUTED DIGITALLY. IN DECEMBER, THE LYRIC PRODUCED AND DIGITALLY DISTRIBUTED A NEW PRODUCTION OF AMAHL AND THE NIGHT VISITORS WITH LIFE-SIZE PUPPETS AND SOCIALLY DISTANCED SINGERS AND MUSICIANS. LASTLY, THE LYRIC WAS ABLE TO PRODUCE BASEBALL: A MUSICAL LOVE LETTER IN THE LATE SPRING TO SOLDOUT MASKED AND SOCIALLY DISTANCED AUDIENCES IN THE LYRIC'S PRODUCTION CENTER. EDUCATION AND ENGAGEMENT ACTIVITIES WERE SEVERELY CURTAILED DUE TO SAFETY CONCERNS THIS YEAR. THE LYRIC DID, HOWEVER, PRODUCE A NEW FAMILY GUIDE FOR THE AMAHL AND THE NIGHT VISITORS PRODUCTION. OPERATIONS WERE ALSO PROFOUNDLY IMPACTED WITH STAFF WORKING REMOTELY FOR THE ENTIRE YEAR. IN ADDITION, STAFFING WAS REDUCED DUE TO PANDEMIC DRIVEN REVENUE LOSSES, ALTHOUGH THE CUTS WERE MITIGATED BY THE PAYROLL PROTECTION PROGRAM. THE LYRIC WAS ABLE TO TAKE ADVANTAGE OF TWO ROUNDS OF PPP LOANS, ONE OF WHICH WAS FORGIVEN IN THIS FISCAL YEAR. THE SECOND IS EXPECTED TO BE FORGIVEN IN THE NEXT FISCAL YEAR. THE LYRIC MADE SEVERAL IMPORTANT INVESTMENTS IN ITS INFRASTRUCTURE DURING THE YEAR INCLUDING, AN IT REFRESH, IMPLEMENTING NEW ACCOUNTING SOFTWARE, IMPROVEMENTS TO ITS PRODUCTION CENTER, AND NEW BRANDING WHICH LAUNCHED IN MAY 2021.
